

# Executive Summary Battery Storage, Smart Grid, and Efficiency Funding and M&A 2019 First Half Report

BATTERY STORAGE, SMART GRID, and ENERGY EFFICIENCY KEY FINDINGS

- Venture capital (VC) investments into the Battery Storage, Smart Grid, and Energy Efficiency sectors came to \$1.7 billion in 43 VC funding deals during 1H 2019 compared to \$843 million raised from 51 deals in 1H 2018.
- Total corporate funding into the sectors, including debt and public market financing, decreased in 1H 2019 with \$2.3 billion in 51 deals compared to \$2.4 billion in 61 deals in 1H 2018.
- Corporate funding in **Battery Storage** came to \$1.9 billion in 22 deals compared to \$689 million in 36 deals in 1H 2018.
- VC funding for Battery Storage companies came to \$1.4 billion in 17 deals in 1H 2019 from \$543 million raised in 30 deals in 1H 2018.
- There were six corporate M&A transactions (one disclosed) involving Battery Storage companies in 1H 2019. There were eight (two disclosed) M&A transactions in 1H 2018.

### Battery Storage Top 5 VC Funded Deals in 1H 2019

- Corporate funding in **Smart Grid** came to \$120 million in 22 deals compared to \$1.4 billion in 13 deals in 1H 2018.
- Smart Grid VC funding in 1H 2019 came to \$120 million raised in 21 deals compared to \$135 million in 11 deals in 1H 2018.

• There were 17 announced M&A transactions (one disclosed) in 1H 2019, compared to five undisclosed transactions in 1H 2018.

- Corporate funding in **Energy Efficiency** dropped to \$264 million in seven deals in 1H 2019 compared to \$376 million in 12 deals in 1H 2018.
- VC funding raised by Energy Efficiency companies in 1H 2019 was \$207 million in five deals compared to \$165 million in 10 deals in 1H 2018.
- In 1H 2019, there was eight Energy Efficiency M&A transactions (two disclosed) while in 1H 2018, there were three M&A transactions (all undisclosed).
