ENERGY STORAGE, SMART GRID, and ENERGY EFFICIENCY KEY FINDINGS

- Venture capital (VC) investments into the Energy Storage, Smart Grid, and Energy Efficiency sectors came to \$6.7 billion during 9M 2022 compared to \$8.2 billion raised in 9M 2021.
- Total corporate funding into these sectors, including debt and public market financing, increased in 9M 2022 with \$25 billion compared to \$15.1 billion in 9M 2021.
- Corporate funding into Energy Storage companies reached \$22 billion in 92 deals in 9M 2022 compared to \$13 billion in 74 deals in 9M 2021.
- VC funding for Energy Storage companies totaled \$4 billion in 73 deals in 9M 2022 compared to \$7.2 billion raised in 60 deals in 9M 2021.
- Twenty-three (23) Energy Storage M&A transactions were executed in 9M 2022 compared to 15 transactions in 9M 2021.

- Corporate funding into Smart Grid companies came to \$2.8 billion in 33 deals in 9M 2022 compared to \$1.8 billion in 28 deals in 9M 2021.
- Smart Grid VC funding in 9M 2022 came to \$2.5 billion in 29 deals compared to \$936 million in 25 deals in 9M 2021.



• Eighteen (18) Smart Grid M&A transactions were announced in 9M 2022 compared to 17 transactions in 9M 2021.

Smart Grid Top 5 VC Funded Deals in 9M 2022

- The Energy Efficiency sector's corporate funding dropped with \$269 million in six (6) deals in 9M 2022 compared to \$348 million in four (4) deals in 9M 2021.
- VC funding raised by Energy Efficiency companies in 9M 2022 amounted to \$269 million in six (6) deals compared to \$5 million in three (3) deals in 9M 2021.
- Two Energy Efficiency M&A transactions were announced each in 9M 2022 and 9M 2021.
